

Action Taken on the basis of above Analysis Outcome 22-23

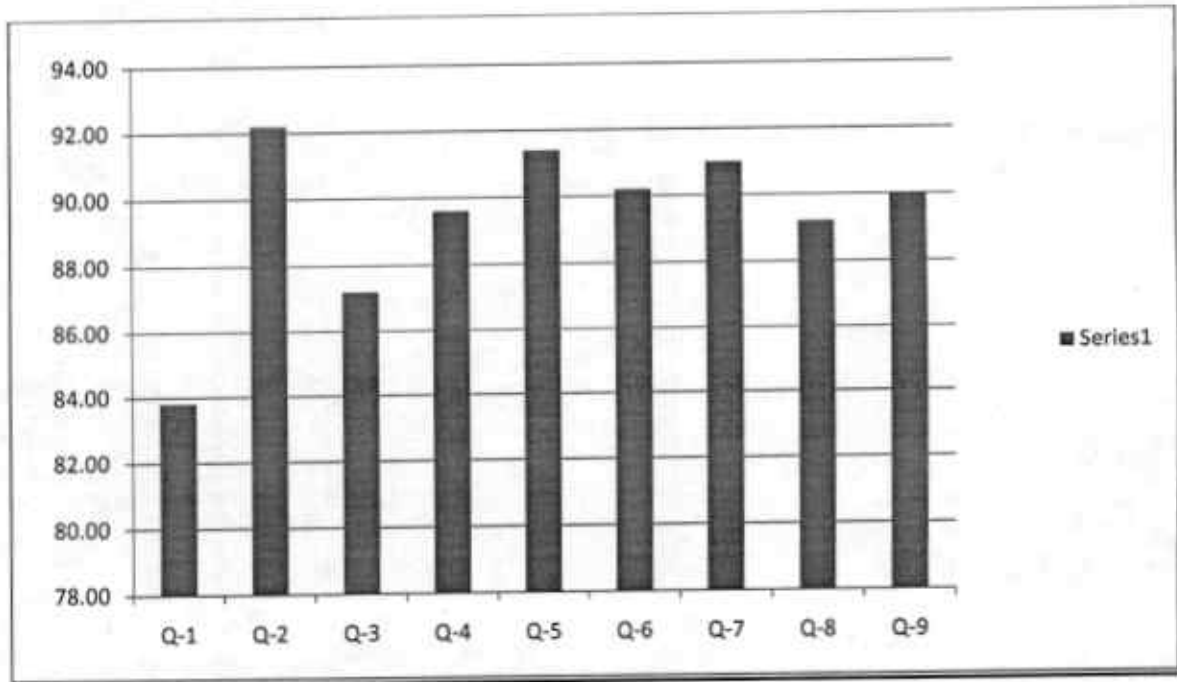

Action Taken on the basis of above Analysis Outcome 21-22

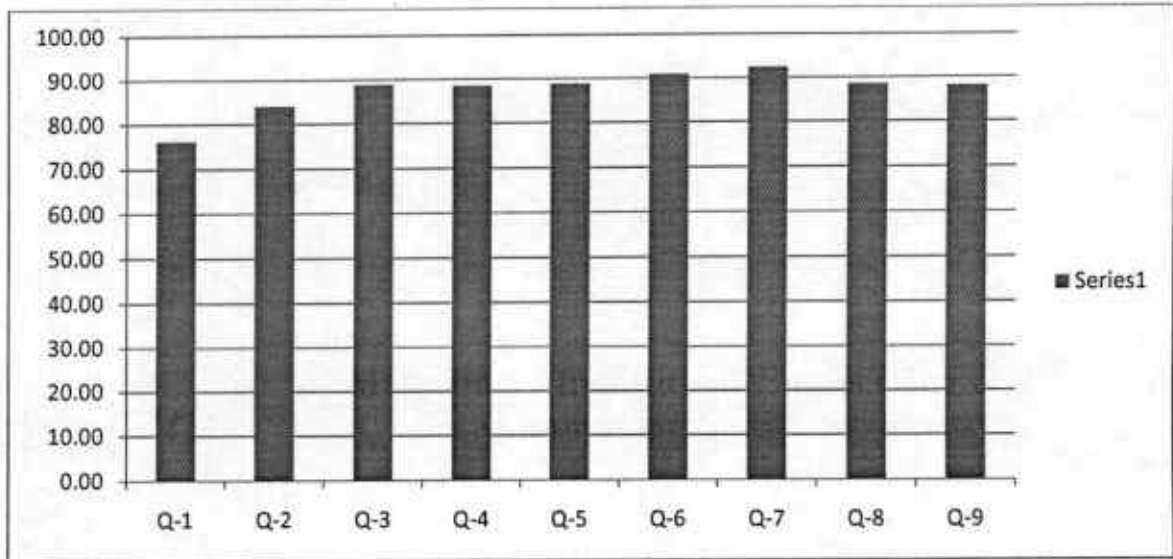

Action Taken on the basis of above Analysis Outcome 20-21

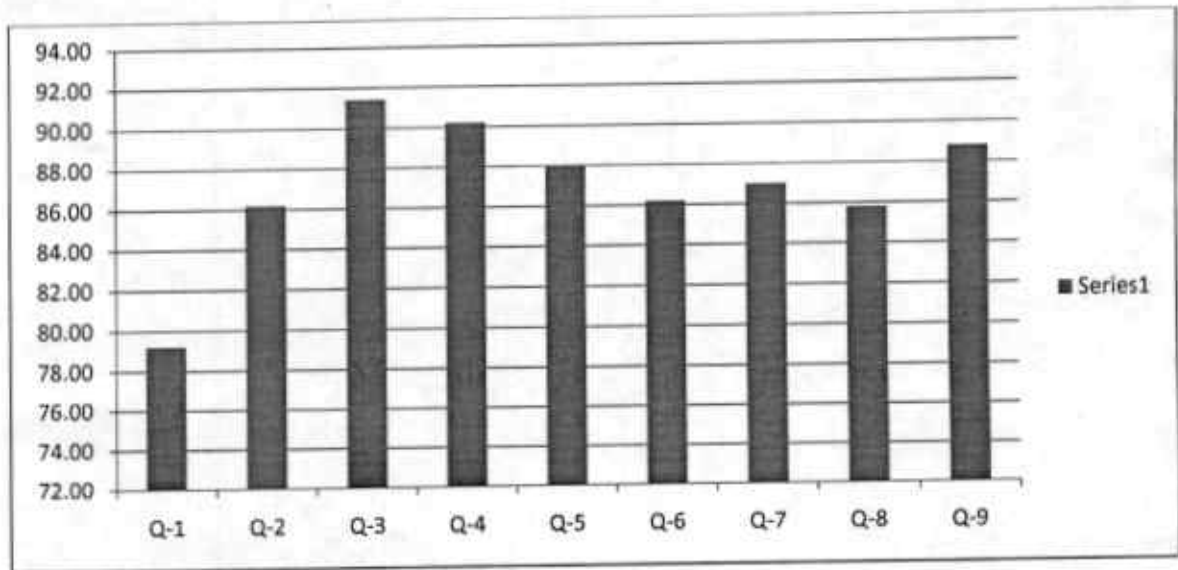
